TRANSFER OF SECURITIES TO THE SECOND BOARD OF THE COLOMBO STOCK EXCHANGE NON – COMPLIANCE WITH THE MINIMUM PUBLIC HOLDING AS A CONTINUOUS LISTING REQUIREMENT

We write with reference to the letter dated 15th November 2019 forwarded by the Colombo Stock Exchange (CSE), received by us on 22nd November 2019, whereby CSE has notified that the Company has been transferred to the Second Board of the CSE, with effect from 15th November 2019.

Accordingly, we wish to inform you the following in terms of Rule 7.13.2.(f) of the Listing Rules of the CSE.

- the Company is not in compliance with the minimum public holding requirements as specified in Rule 7.13.1 of the Listing Rules of the CSE
- ii. The details pertaining to the status of the minimum public holding of the Company as of 31st October 2019 are as follows;

- The Company made an announcement on 1st December 2015 detailing the 'Action Plan' of the Company, which comprised of the following;
 - Sale of plantation estate of the Company in Malaysia and distribute proceeds thereof to the shareholders
 - Make arrangements for Goodhope Asia Holdings Ltd (GAHL), the Holding Company to acquire the investment of 13.33% made by the Company in Shalimar Developments Sdn. Bhd. (SDSB) and the sale proceeds therefrom to be distributed to the shareholders
- The Company has completed the sale of its' plantation estate in Malaysia and has distributed the net proceeds therefrom to the Shareholders of the Company via Repurchase of Shares and an Interim Dividend payment. The Company is yet to complete the next step of the action plan as stated above.

Accordingly, we will communicate to you once the said Action Plan is completed.
