We wish to inform you that as per Article 16(1) of the Articles of Association of the Company, the Directors of Pegasus Hotels of Ceylon PLC have recommended to declare a First & Final Dividend of 50 cents per Share on the Ordinary Share Capital of the Company for the Financial year ended 31st March 2015 subject to Shareholders' approval at the forthcoming Annual General Meeting scheduled for 17th June 2015 and the said dividend would be paid to the shareholders on 26th June 2015.

The details of the Dividend distribution is given below;

- 1. First & Final Dividend of 50 cents (per share) amounting to total dividend outflow of Rs. 15,195,769/-.
- 2. Out of the First & Final Dividend, 16 cents (per share) amounting to Rs. 4,935,377/would be paid out of dividend income received by the Company and would not be subjected to tax; and
- 3. 34 cents (per share) out of the First & Final Dividend amounting to Rs. 10,260,392/would be paid out of profits and income of the Company, which would be subject to a dividend tax of 10%.

A certified true copy of the extract of the Minutes of the Board Meeting held on 12th May 2015 pertaining to the approval of the First & Final Dividend and Solvency Certificate issued by the Directors of the Company are enclosed for your reference.
